### HomePlace's Independent Visitor program

In 2022, we started our Independent Visitor Strategy. Modelled on the Community Visitor Scheme, Mr Tony Rankine, visited six people we supported during the year. These visits enabled the participants to share their thoughts on the support they were receiving from HomePlace, and whether improvements need to be made so that they can lead a better life. It provided Mr Rankine an opportunity to make sure the participants were safe, healthy and leading an active life.

Reports from the visits have provided valuable feedback regarding participant safety, health and well-being and areas for improvement.

In late January 2023, a second visitor, Ms Leslie Wightman, started. Many of you will know Leslie from her time on the HomePlace Board. With the addition of Leslie's skills and capacity, the Visitor Strategy will enable two visits for each of the six participants in 2023.


We hope that through the contribution of your thoughts and ideas to this project, we can make HomePlace even better in the years to come.
