ROYAL COMMISSION

INTO VIOLENCE, ABUSE, NEGLECT AND EXPLOITATION OF PEOPLE WITH DISABILITY

Why set up a Royal Commission?

In Australia, royal commissions are the highest form of inquiry on matters of public importance. Recent inquiries and reports have shown that people with disability are more likely to experience violence, abuse, neglect and exploitation than people without disability. What we learn from the Royal Commission will help to inform Australian governments, institutions and the wider community on how to prevent, and better protect, people with disability from experiencing violence, abuse, neglect and exploitation in the future.

What is the scope of the Royal Commission?

The Commissioners have been directed to inquire into violence, abuse, neglect and exploitation of people with disability. The Royal Commission's Terms of Reference cover what should be done to:

- prevent, and better protect, people with disability from experiencing violence, abuse, neglect and exploitation
- achieve best practice in reporting and investigating of, and responding to violence, abuse, neglect and exploitation
- promote a more inclusive society that supports the independence of people with disability and their right to live free from violence, abuse, neglect and exploitation.

The inquiry will cover all forms of violence against, and abuse, neglect and exploitation of, people with disability, in all settings and contexts.

How will people with disability be supported?

The Royal Commission will advise about accessibility arrangements for people with disability in the coming months.

The Government will also provide individual advocacy supports and counselling support services for people engaging with the Royal Commission.

The Royal Commission has just announced Community Forums in Adelaide & Gawler

Community forums are a key way people with disability and others in the disability community can directly share their personal experiences with the Royal Commission.
